- Joint Dissemination: Coordinated participation in conferences, co-branded campaigns, and cross-promotion via digital and media channels
- Policy Engagement: Co-developing policy briefs and recommendations aligned with EU strategies
- Standardisation and Method Harmonisation: Exploring synergies in methods, Key Performance Indicators, risk models, and community engagement
- Community Empowerment: Advancing inclusive, participatory methods and co-creation with citizens and other key stakeholders

- Quarterly coordination meeting with ad-hoc working groups
- Shared digital workspace to manage documents, calendars, and communication

- Cross-project citations and reuse of tools/datasets
- Policy influence: adoption or reference of recommendations
